Ms. Van Es,

You advised this morning when I attended your office to enquire about procedural issues related to the above Council meeting, to find/elect a speaker who should address all concerns pertaining to the Stone Garden Drive development, to present on behalf of all owners / those who have concerns, and who require a response.

Be advised that no one person has made it known that they are prepared to do as you suggest "act as the spoke's person". However, I have been asked by two-home-owners to bring their specific concerns to your attention. In doing so please note: I DO NOT SPEAK FOR, OR IN ANY WAY REPRESENT THE COMMUNITY - WRIT LARGE.

Owners Question(s)

- 1. When the Stone Garden area was approved, was side-walk construction the responsibility of the developer. If not, who's responsibility was it for putting sidewalks in for pedestrian safety?
- 2. When this community (Stone Garden) was developed, was it in the approved development plan for Stone Garden Drive to be a through street, therefore having to take down the existing fence separating two different communities?

My Personal Presentation and Enquiry:

My participation here this evening is not to necessarily to complain, more importantly, for you to shed some light on a number of issues:

1. If indeed you will be opening Stone Garden Drive to two-way traffic, and recognizing that children from the Stone Heaven development, and seniors from within our development, and from outside our development, will be using Stone Garden Drive to access and egress from the Mandalay development, how do you intend to get pedestrian safely from one area to the other, given that there is no existing sidewalk?

NOTE: usable width of Stone Garden Drive road surface = 32ft usable width of Stone Garden Crescent road surface = 21ft

- 2. It is my understanding that there was an agreement with the previous council, that some form of traffic control would be installed to control access and or vehicle speed, at the transition of Stone Garden and the Mandalay development area. Is this still being considered, if so, what control measure have you decided upon? (example: some form of gate or moveable barrier)
- 3. I am sure that council has considered the inherent danger of allowing children (of all ages), to say nothing of the mobility concerns experienced by many of the old and infirm, to be in such close proximity to vehicular movement along an already restrictive roadway. That being said, WILL YOU CONSIDER OTHER OPTIONS FOR A SIDEWALK LOCATION, THAT WILL AFORD A GREATER DEGREE OF SAFETY FOR ALL PEDESTRIANS AND DRIVERS OF VEHCLES?

I wish to register my concerns with development around the proposed supermarket. I am ok with the store itself, even though the original plan was for a strip mall. The store will be about 1.5x larger than the co op. In talking to workmen, I know that long term plans are for a gas bar (Another one? Really??) and fast food restaurants. The permit application is not for this, so will not address this at this time.

My concern is the plan to allow free flowing traffic on Stone Garden Drive. As concerned citizens, we made a presentation to council 3 years ago asking for the road to be kept closed. Our understanding was that Council heard our concerns and respected them. When the fence was opened up to allow foot and bike traffic, I was supportive. As mentioned in the presentation 3 years ago, Stone Garden Drive is narrow and there are no sidewalks. Parking is not allowed on Stone Garden Crescent (where I live) and so our guests have to park on the Drive and walk in. It is also where we park our RV from time to time. This is an active neighborhood and many people walk on the street, with or without dogs. Keep in mind that this is a seniors area, so many of us are not limber and move slowly with canes etc. Increased traffic flow to and from the grocery store, especially from Stonebridge area, but possibly others too coming off 2A puts all of us at risk. Will the increased traffic necessitate restricted parking? If so, where will guests park? Where will we park our RV when loading/unloading it? Also troubling is the plan to open it up during construction phase which will bring more trucks and workers onto our narrow road.

Coming out on Stone Garden Crescent onto the Drive, vision is obstructed by a wood fence. Even now, we have seen near misses because kids zip through on scooters and are not visible until in the intersection. The current risk is concerning, but with added traffic, it will be downright dangerous. We do not want to see anyone hurt but that is inevitable if traffic is allowed through. I talked to someone in the Development Office, and he mentioned that there was safety concern for traffic turning left out of Stonehaven onto 2A and then left again into Mandalay. Seriously? That is more of a concern than putting all of that traffic along with senior pedestrians and children playing on a narrow road? I think the opposite is more likely. People southbound on 2A will turn onto Stonehaven to shortcut through Stone Garden Drive to access the store.

At our meeting in 2020, it was suggested that allowing emergency vehicles through was important and therefore a gate of some kind would allow firetrucks etc through without putting the burden of traffic on the Drive. I would like to propose that this be considered again.

We moved to here 6 years ago from Calgary and chose Carstairs (and not Airdrie) because it really was 'An authentic small town.' How long will that be true with Mandalay, Scarlet Ranch, Kitstone and who knows what else in the works. As you make decisions that impact all of us, please consider what makes this town great, and work to preserve it, not just expand the tax base. A small step towards that would be to protect the seniors and children that use Stone Garden Drive for walking and biking.

I invite each of you to come and look for yourselves. I or anyone in our community would love to show you.
